**Making an objection**

If you do not agree with the decision in this letter, you can submit an objection on the basis of the General Administrative Law Act (Algemene Wet Bestuursrecht). You must submit your objection within 6 weeks after the date at the top of this letter. In your objection you should explain why you do not agree with this decision. You should write your objection in Dutch. If we receive an objection in another language, we may ask you for a translation.

*Online*

If you would prefer to write a letter, you should send your objection to:

Your objection must include, and be accompanied by, at least the following:

- The date, your name, address and signature.
- The decision you are objecting to (please enclose a copy of the decision letter, or the letter's reference number).
- The reason why you do not agree with the decision.
- Documents relating to the objection (for example photos, letters or notes).

If you would like to provide a verbal explanation of why you disagree with the decision, please state this in your objection. You should do so within 6 weeks after the date at the top of this letter. Please also include your telephone number in your objection.
